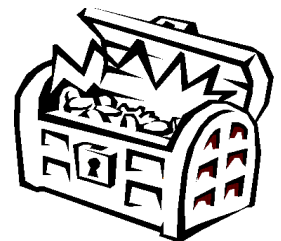

It is intended to run the Corona Worldwide 100 Club 2018 along similar lines as in 2017 with three draws with four prizes

1. The Club will operate with a minimum of sixty members.
2. The premium will be £30, paid either by cheque or by a standing order for six monthly payments of £5.00.
3. There will be three draws a year which will take place at the Executive Committee Meetings in May and September 2018 and at the Annual General Meeting in March 2019 under the supervision of the Trustees and Officers of the Society
5. Individuals may form syndicates or take out multiple premiums, as may Branches and Groups. However, one named person must be responsible for each syndicate.
6. Application forms with cheques should be received before the 30th April 2018; application forms with standing orders should be received no later than 15th April 2018.
7. On receipt of a completed application form, together with a cheque or completed standing order mandate, members will be issued with a number for each premium for which they have paid.

In 2017 the Corona Worldwide 100 Club attracted sixty members, and needs at least sixty to run. This provided a prize fund of £900 and £900 for the Society. What a wonderful way to support Corona Worldwide!
